POSSESSION: Buyer agrees to take possession of said goat(s) on this agreed Date of Sale: _____. On agreed upon Date of Sale and upon full payment of said goat(s) as set forth in contract below, Seller agrees to provide ADGA registration papers and transfer of ownership form(s) to Buyer. Buyer agrees to complete the full transfer of ownership through ADGA and/or AGS at Buyer's expense within 30 days of date of sale. (Castrated goats will not come with ADGA registration papers & will not be tattooed, unless specifically requested by buyer.)

Dam raised kids are ready for pick up between 8-12 weeks old at the discretion of the breeder.
Dam raised kids are raised in the herd with their mothers and other goats (and with lot of human attention!)

CONTRACT:

1. Seller makes no guarantees, expressed or implied, including any guarantees to health, color, height, reproduction, show quality, milk production, etc. We do not offer any health or wellness guarantees after the goat has left our property since we cannot control the management of the animal(s) once it leaves our farm. We encourage Buyers to understand that travel and management change is stressful to the goat(s) and the Buyer is encouraged to make environment & feed transitions slowly to reduce stress to said goat(s). We will supply Buyer with a portion of feed(s) that the goat has been used to, to allow for a gradual switch to the new feed(s).

2. Seller guarantees said goat(s) is healthy at time of sale and Buyer has the option to review the condition and health of the goat, including any veterinary examinations, at Buyer's expense. Seller will provide detailed health records for goats born on our farm.
3. All dam-raised buck & doe kids will be disbudded, tattooed, vaccinated at least once for CD/T and registered with ADGA before leaving Haymaker Farm, unless Buyer specifies horned or unvaccinated goats.
4. All wethers will be disbudded, vaccinated at least once, and castrated before leaving Haymaker Farm.
5. Should a doe be sold as a pet/non-breeding animal, no registration papers will be released or given to Buyer at any time.
6. Haymaker Farm reserves the right to retain any kid from any breeding, regardless of reservations.
7. If the Buyer's first choice kid is not available, Buyer has the option to choose an available kid from another breeding OR roll over to the following year.
8. We care deeply for the welfare of the animals we've brought into the world. We reserve the right to refuse to sell an animal at our discretion if we are not confident in the ability of the Buyer to adequately care for the animal.
9. Buyer has the right to review current blood test results, DHI milk test results, and Linear Appraisals.
10. Once an animal has been chosen and specifically reserved, reservations require a non-refundable deposit accompanied by this signed contract.
11. Deposits are non-refundable unless Buyer's reservation cannot be filled.
12. Reserved goats must be picked up within 7 days of the agreed upon sale date. Reserved goats not picked up within 7 days of the agreed upon sales date will be charged \$3/day per goat board, to be paid by Buyer before goat leaves the farm. If said goat(s) is not picked up within 14 days of the agreed upon sales date (unless other arrangements have been mutually agreed to) the Buyer's reservation will be forfeited, including all monies paid, and said goat(s) will be retained or placed for sale.
13. The Buyer is responsible for transportation of the animal and all transportation costs. Seller assumes no responsibility for transportation arrangements or costs associated with transportation, nor will Seller be responsible for accepting or transferring funds intended for shipment of the animal. Furthermore, Seller is not responsible for death or injury associated with transportation.
14. In the event of the loss or injury of said goat(s) prior to delivery date to Buyer, Seller shall refund full deposit to Buyer.
15. Reserved goat(s) will not leave Haymaker Farm, for any reason, until full payment is received.
16. For bred animals, Seller offers no guarantee as to quality or number of kids born. Seller has no control over abortion, absorption or loss of fetus, or overall health of kids and/or doe after transfer to Buyer due to stress, management, natural causes, etc. Any kids who are the result of a doe purchased bred MUST carry the "Haymaker Farm" herd name and have ear tattoos of the farm where the kids are actually born (Buyer's tattoo letters).

We request that Haymaker Farm be given first refusal if at any time you decide to sell an animal purchased from us.

If at any time you are no longer able to keep the animal/s you have purchased from us, we may be able to take that animal back provided the health status of the animal matches the health status of our herd (CAE, CL, & Johnnes Free).

Upon breach of this AGREEMENT by one party the other party shall have the option to terminate sale. This AGREEMENT shall be governed by the laws of the State of Maine.
